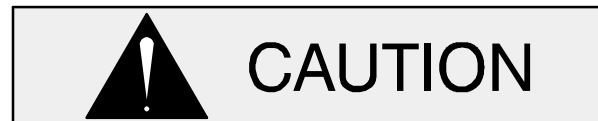
WARRANTY INFORMATION

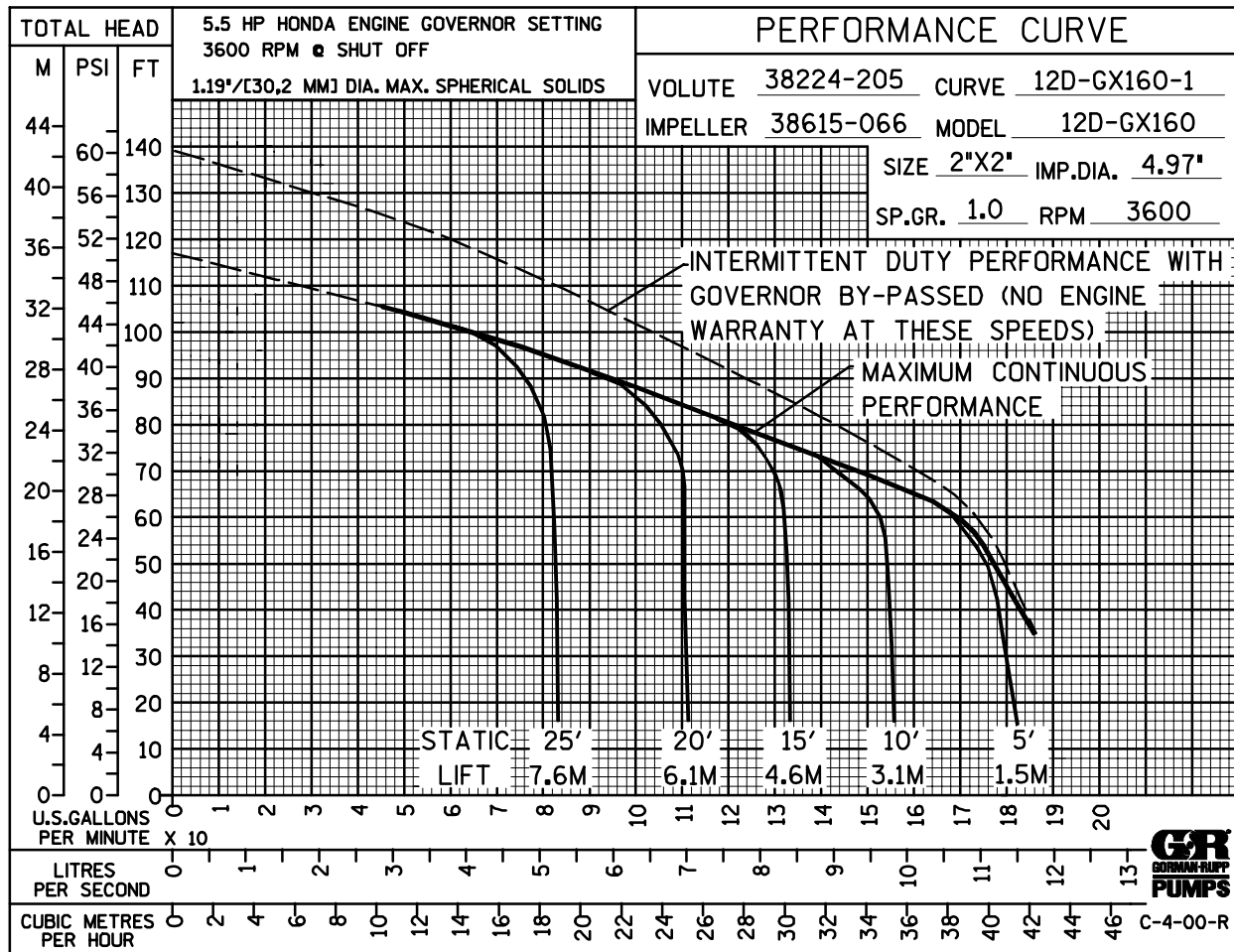
PERFORMANCE CURVE

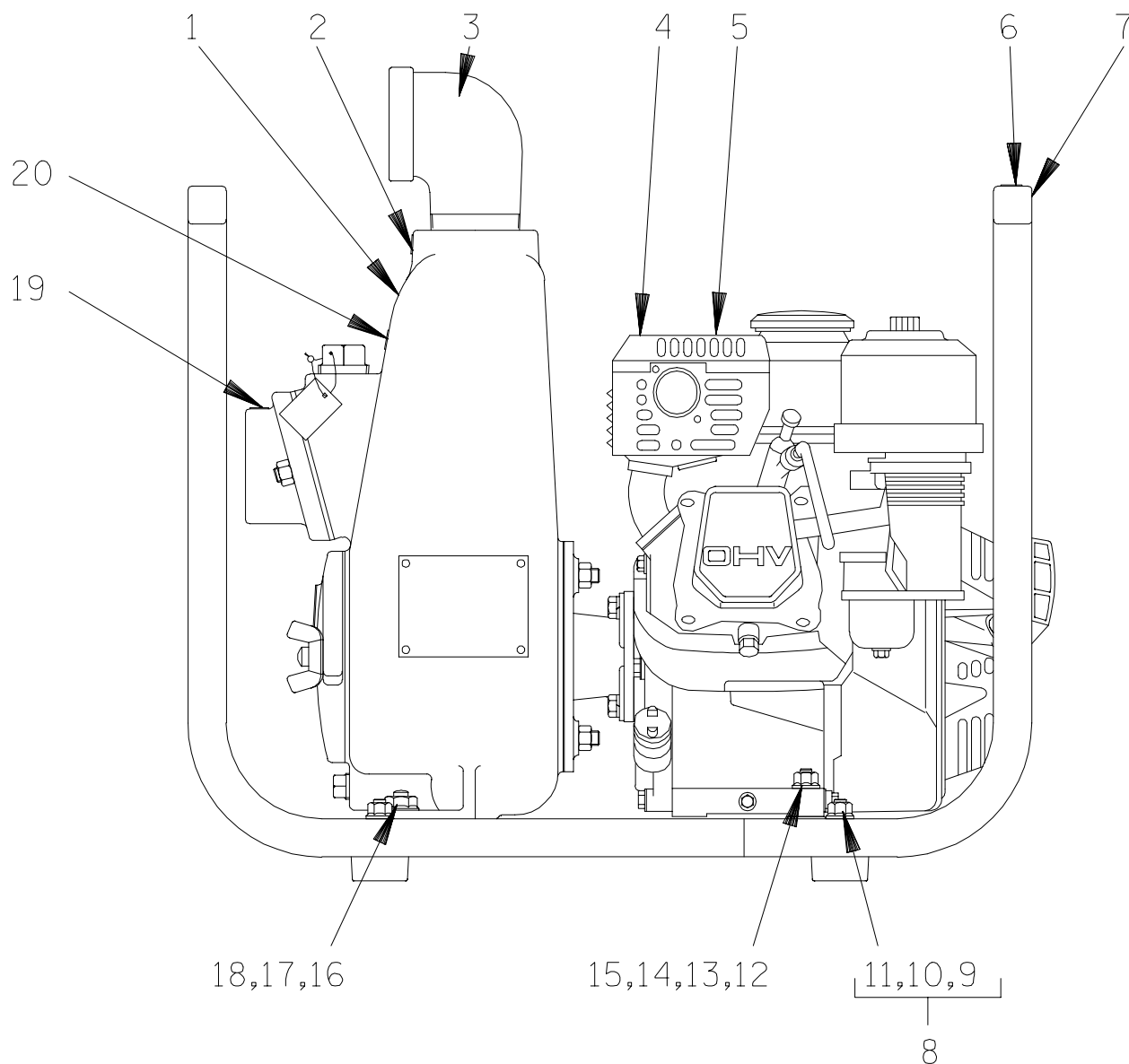


Pump speed and operating condition points must be within the continuous performance range shown on the curve.

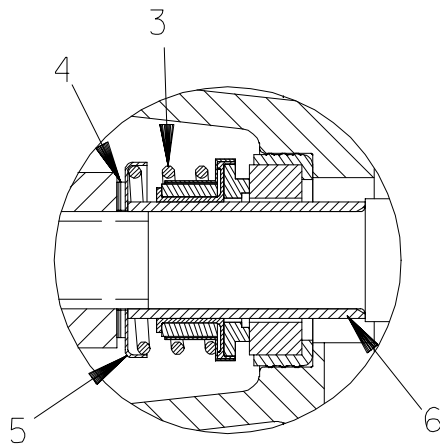

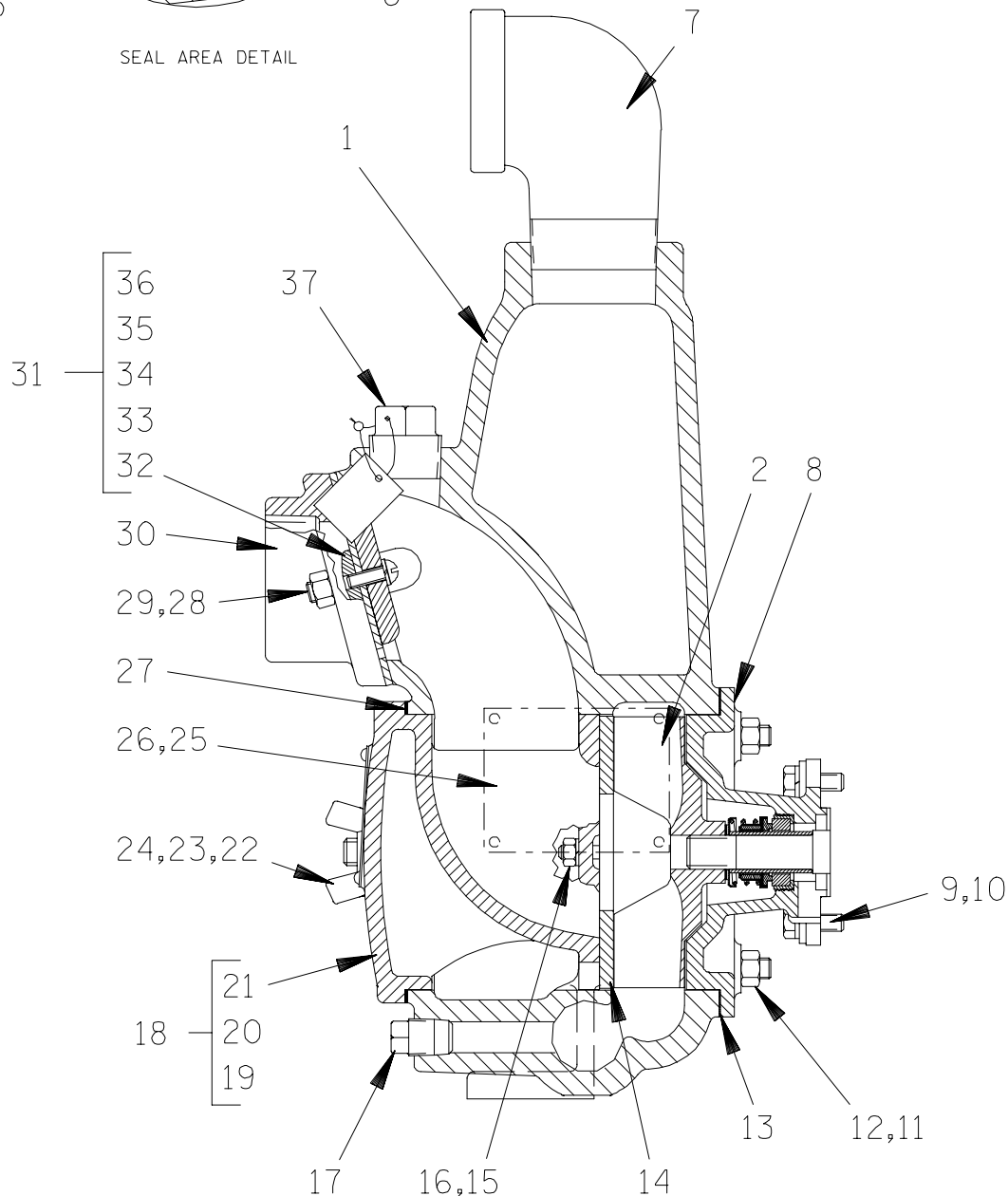
